At the outset, we are happy to associate with the reputed technical university under your leadership. Our sincere appreciation and thanks for the continued efforts made by the university to raise the quality of technical education in Tamil Nadu.

Regulations 2017 is designed taking into account various knowledge and skills enhancement of Engineering graduate with latest technological inclusions. As an academic community, we welcome many of the changes like, Employability Enhancement courses, open electives, Industrial training etc... Facility to undergo industrial training every year, giving seminars, value added courses, are the real boon to the students who are willing to learn and abreast with change in technologies. The chance of doing the project for the whole semester will definitely of use to the fast learners. We express our thanks for this initiative.

At the same time, we would like to represent humbly certain issues that students might find difficult in clearing the paper and graduate the course. Few of the clauses of R2017 are going to impact heavily on the successful completion of the course by the average and below average learners.

- 1. As per clause 14.2, if a student fails to secure a pass in a theory course (except electives), the student shall do reappearance registration only along with regular students for that course in the subsequent semester, when offered next, earn continuous assessment marks and attend the end semester examination This directly affects the students as the number of attempts a student can take to clear the subjects is made half and also he has to earn internal marks when the course is offered next.
- As per clause 6.1, the total number of credits that a student is allowed to register per semester cannot exceed 36 - This will provide the students to reappear for the examinations of only 3 or 4 failed subjects.



While the logic behind the above clauses as compelling the students to perform well sounds good, we should also consider the present status of the pass percentage in engineering colleges situated in rural and semi urban areas, which is very pathetic. Reduction in the eligibility criteria and reservation to socially suffered people make the life of the students in engineering institution a tough one.

It is our bounden duty to welcome any positive changes for the student community, but tough measures taken in big volumes will only affect the students' motivation and form a negative picture over the engineering education. Hence we humbly request your good office to look into the matters sympathetically and do some favorable actions for the student masses who are finding it difficult to successfully complete the course. We hope favorable decisions will be made after analyzing the ground reality thoroughly.

We feel proud in affiliating with your university and thank you for your thoughtful process of making the engineering education a fruitful one. Let us regain the glory of engineering education in Tamil Nadu, which would benefit not only the students but also the society at large.
